# **Federal Update on Recycled and Other Green Products -** Dana Arnold (Office of the Federal Environmental Executive)

- Ed Piñero has been appointed by the President as the new Federal Environmental Executive.
- Online green purchasing training course has been constructed and is available for all government and military employees. The training is broken into six modules and is designed to be fun as well as educational. The expectation is for Contracting Officers to take all six modules with everyone else taking the first four. To be allowed to take the course, presently you have to have an e-mail address ending either with .gov or .mil. OFEE is working with the Office of Personnel Management to open the course to those Federal contractors who do not have .gov or .mil in their e-mail addresses. - When purchasing, we all need to be aware of selecting non-ozone depleting substances. Alternative products are listed at <a href="http://www.epa.gov/ozone/snap/lists/index.html">http://www.epa.gov/ozone/snap/lists/index.html</a>.
- The U.S. Environmental Protection Agency has issued a list of five priority chemicals which agencies must reduce usage of by 50% by 2006. These chemicals are cadmium, lead, mercury, naphthalene, and PCBs.
- The U.S. Postal Service has been working on developing environmentally benign adhesives. Only one company is making such labels at this time. For information on environmentally benign adhesives, see ofee.gov.
- Closing the Circle awards
  - Nomination website is now open (ofee.gov).
  - Categories are the same as last year except for the addition of one new category: alternative fuel vehicles, alternative fuels, and reduced fleet petroleum usage.
  - To be considered for the Green Purchasing Award, the organization must have a robust program for purchasing recycled products as well as either biobased products or other environmentally preferable products, especially best examples of acquiring, using, or validating products or services that have a reduced impact on human health and the environment when compared with competing products or services that serve the same purpose; an outstanding improvement to a process that resulted in significant monetary savings and benefit to the environment; or product testing that led to the approval and use of environmentally preferable products or services. Preference will also be given for outreach programs/projects or educational efforts designed to promote the green purchasing objectives of Executive Order 13101.
  - Energy efficiency projects and products should be submitted as FEMP awards (http://www.eere.energy.gov/femp/services/awards fewm.cfm)

**Question** (Linda Maseros) - When will the U.S. Department of Agriculture designate the biobased products Federal agencies are to purchase?

**Answer** (Dana Arnold) - The rule is supposed to be published by the end of the calendar year though that is becoming more doubtful with each passing day.

# Newly Designated Recycled Products: Specifications and Suppliers – Sue Nogas (U.S. Environmental Protection Agency)

- The third Comprehensive Procurement Guideline update (CPG IV), published April 30, 2004, designated seven new products for purchase with recycled content:
  - modular threshold ramps
  - o nonpressure pipe (typically sanitary drainage pipes without pumps)
  - office furniture (office furniture companies alerted to this at the GSA Expo)
  - o blasting grit
  - rebuilt vehicular parts
  - bike racks
  - roofing materials
- CPG IV also revised the designation for three items:
  - o cement and concrete (added cenospheres and silica fume as recovered material options)
  - polyester carpet (for moderate end-use only)
  - railroad grade crossing surfaces (added recovered wood and plastic as recommended recovered materials)
- Reporting on the seven new products will be required beginning May 2, 2005.
- The Recovered Materials Advisory Notice IV (RMAN IV) contains EPA's
  recommendations for purchasing the new products, including recommended recovered
  content levels and product specifications. This information can be found at

**Question** (Kristin Klossner) – How does the percentage of "post-consumer" content relate to the percentage of "recycled" content shown on the specifications chart?

**Answer** (Dana Arnold) – The post-consumer content is a part of the total recovered content recommended. If the chart shows 30% post-consumer and 50% total recovered content, that means the product is recommended to have 30% post-consumer, 20% pre-consumer, and 50% virgin content.

**Question** (Dennis Dobbins) – If a product does not meet the percent required, then is a lower percent acceptable?

Answer (Sue Nogas) – Yes, but only under certain conditions. The bottom line is that procuring agencies must buy a CPG product with the highest level of recovered content practicable. The EPA's recommended post-consumer and total recovered content percentages are only recommendations and reflect what EPA found on the market at the time the product was designated. A procuring agency is allowed to buy a product with a lower percentage of recovered content if: 1) the agency is unable to find, when they need it, a product containing a higher percentage of recovered content; 2) the product at a higher percentage is unavailable at a reasonable price, or 3) the product at a higher percentage does not meet the agency's performance requirements.

**Question** (Dana Arnold) – Are the recycled content requirements for roofing materials in sync with the EnergyStar requirements for roofing materials? **Answer** (Sue Nogas) – I will look into it and let you know.

**Question** (Teresa Loschke) – On the website, are items identified as being recycled or non-recycled? Do vendors specify information on recycled content for their products? If a vendor is listed on EPA's Supplier Database website, does that mean all the vendor's products contain the specified recovered material?

**Answer** (Sue Nogas) – Only vendors who carry products that meet the recommended recovered content levels in the RMAN appear in the Supplier Database. Many times a vendor shown on the EPA Supplier Database, however, will have non-recycled products in addition to the recycled products and will need to be prompted to give you the recovered-content information.

# DOE Memorandum on Environmentally Preferable Purchasing/Biobased Products – Richard Langston (DOE-HQ Office of Procurement and Assistance Management)

- The Director of the Office of Procurement and Assistance Management issued a
  memorandum on August 6, 2004, encouraging all DOE Procurement Directors and the
  Purchasing Managers for DOE's major site and facility contractors to include
  environmental preferability and, in particular, biobased content, in their contracts and
  purchase orders (<a href="http://professionals.pr.doe.gov/ma5/MA-5Web.nsf/WebAttachments/FLASH2004-23attachment%202/\$File/FLASH2004-23attachment%202.pdf">http://professionals.pr.doe.gov/ma5/MA-5Web.nsf/WebAttachments/FLASH2004-23attachment%202/\$File/FLASH2004-23attachment%202.pdf</a>).
- The Office of Energy Efficiency and Renewable Energy (EERE), through its Office of the Biomass Program, is urging the Department and its management contractors to be early adopters of the Buy Bio Program. Because biobased content is used to replace oilbased content, buying biobased products reduces our use of a finite resource and need to import foreign oil and, thereby, enhances our energy security.
- The Farm Security and Rural Investment Act, as well as Executive Orders 13101 and 13134, provide for a preferred procurement program for biobased versus similar petroleum based products, and is modeled after EPA's Affirmative Procurement Program for recycled content products. USDA will develop a list of products that Federal agencies and their contractors will be obliged to purchase with biobased content.

**Question** (Gene Iley) – Are we going to be reporting by category for biobased products in the future?

**Answer** (Dana Arnold) – No one is sure at this time what type of reporting for biobased products will be required. OFEE and Office of Federal Procurement Policy will be working with the agencies to develop a reporting system that reflects as much as possible purchasing behavior changes instead of data points for each product. The problem is how do we capture such information and have it reflect the actual situation?

To have opportunity to be forwarded for a White House Closing the Circle Award as well, include description of your complete Environmentally Preferable Purchasing Program, highlighting the biobased initiatives undertaken this year and your recycled products program along with any other EPP components
