A Call for Abstracts has been released to solicit presentations for the *2012 GreenGov Symposium – Leading by Example*. Abstracts should relate to innovative sustainability efforts in Federal, private sector, and state and local government operations, and focus on innovations in technology and policy that demonstrate leadership in these areas and will ultimately result in sustainability across the Federal community. FedCenter Currently Accepting Nominees for the 2012 GreenGov Presidential Awards

Nominations are now being accepted for the 2012 GreenGov Presidential Awards. As in past years, the awards categories include Sustainability Hero; Green Innovation; Lean, Clean, and Green; Good Neighbor; Green Dream Team; and Building the Future. To be eligible for an individual award, the nominee must be a Federal civilian or military employee. For team awards, eligibility may include a Federal partner including a Federal contractor, tribal/state/local agency, or non-profit organization. Nominations must be submitted by a Federal employee through the FedCenter website, www.fedcenter.gov between April 23, 2012 and June 15, 2012. Agency 2012 Sustainability Plans

Earlier this year, CEQ hosted workshops for agency leadership on the 2012 Sustainability Template. The template for the 2012 agency sustainability plans has been updated from last year and is available in the OMB MAX Data Collect system.

Memorandum on Sustainable Product Procurement

On February 21st, President Obama signed a Memorandum on [Driving Innovation and Creating Jobs in Rural America through Biobased and Sustainable Product Procurement](#). The Memorandum reinforces section 2 of Executive Order 13514, which requires agencies to advance sustainable acquisition. Further, it directs Senior Sustainability Officers and Chief Acquisition Officers to verify that biobased considerations are included where appropriate. The U.S. Department of Agriculture will continue to designate categories of biobased products as eligible for preferred purchasing.

Greenhouse Gas Accounting Protocol Posted for Public Comment

A draft revision to the Federal Greenhouse Gas Accounting and Reporting Guidance is currently posted to the [Federal Register](#) for a 30-day public comment period. Once revisions to the Guidance are finalized and distributed, the accompanying technical support document will be reissued. Any changes will be effective for reporting for FY 2012. DOE and OFEE host Better Buildings Case Competition

In March, students from across the country came to the White House to [present ideas for energy efficient buildings](#). University teams—led by their respective energy club—tackled cases that focus on a number of the most common and most stubborn barriers to energy efficiency in the private sector, and in state and local settings. The event supported the *Better Buildings Challenge*, a national energy efficiency leadership initiative and a core element of President Obama's plan to make commercial buildings 20% more energy efficient by 2020. Army's Largest Renewable Energy Project Part of \$61 Million Energy Contracts

The U.S. Army has awarded three Energy Savings Performance Contracts with a total value of \$61 million, including one that will result in the largest renewable energy project executed to date by the Army. These three projects will save the Army 267 billion British thermal units, or BTUs, annually and will provide the Army with 8.2-megawatts of renewable power capacity.
