
### **DHS** Overview



#### DEVELOPMENT AND USE OF STRATEGIC SOURCING CONTRACT VEHICLES

#### Purpose

This directive identifies the policy for developing and using Department of Homeland Security (DHS) strategic sourcing contract vehicles. Strategic sourcing contract vehicles are also known as DHS-wide and Department-wide contract vehicles.

#### II. Scope

This Directive applies throughout DHS, with the exception of the Office of Inspector General.

DHS Management Directive 0730.1, Strategic Sourcing Group Operations, and DHS Management Directive 731, Strategically Sourced Commodities Policy and Procedures, are superseded for contracts governed by this Directive.

#### III. Authorities

- Title 6, United States Code (U.S.C.), Section 341 and 342, "Under Secretary for Management," and "Chief Financial Officer"
- B. Title 41, U.S.C., Section 1702, "Chief Acquisition Officers and senior procurement executives"
- Federal Acquisition Regulation (FAR) Part 7 Acquisition Planning
- D. The Office of Management and Budget (OMB), Office of Federal Procurement Policy Memorandum, "Development, Review and Approval of Business Cases for Certain Interagency and Agency-Specific Acquisitions," September 29, 2011.



### Contract Language and Requirements

**C.6.9.6 EPEAT Report** The Contractor shall provide the EPEAT report on a quarterly basis. Each quarterly report shall quantify the number of EPEAT registered and non-EPEAT registered products purchased or leased under this contract for the specified quarter. Not all items must be reported. <u>Items that must be reported include Desktop Computers</u>, Monitors, Laptop Computers, Televisions, Multifunction Devices, and Printers. The information must be reported in the template form provided at Chapter D, Attachment 2, and submitted to the IDIQ COR and the IDIQ CO and cc to the DHS Environmental Program Manager at ocaosustainabilityreports.hq.dhs.gov, no later than the 15th of the month following the quarter being reported on. <u>If non-EPEAT registered products</u> are sold and reported, a brief explanation of procurement background or justification shall be included in the report. An EPEAT report is not necessary if there were no purchases for that quarter.



## Contract Language and Requirements

When an ordering activity specifies personal computer products that are not EPEAT registered and suitable EPEAT products are available, the Contractor shall:

- Notify the requester of the requirement to purchase the EPEAT product; and
- Provide a suitable alternative(s) that meet the EPEAT registered requirements.

- Please identify the quantities of desktop computers, monitors, laptop computers, televisions, multifunction devices and printers that were purchased or leased by the Department of Homeland Security that are Electronic Product Environmental Assessment Tool (EPEAT) registered, the EPEAT registration level (Bronze, Silver or Gold) and the quantities that are not EPEAT-registered.
- 2. Quarterly reports are due 15 days after each quarter of the fiscal year: Jan. 15, April 15, July 15, Oct.15.

- ✓52.223-15 Energy Efficiency in Energy-Consuming Products
- ✓52.223-14 Acquisition of EPEAT-Registered Televisions
- ✓ 52.223-16 Acquisition of EPEAT-Registered Personal Computer Products



### Lessons Learned

- ➤ Incorporating FAR requirements as part of contract language
- Communicating directly with vendors and purchasing officials
- ➤ Purchase card holders need to have <u>updated</u> information
- ➤ Vendor reporting
  - 25 45 quarterly reports
  - 20% require additional correspondence with vendor
  - Corrective actions with field
  - About 12 hours a quarter



### **EPEAT Totals**

## **History**

- ➤FY10 no data, no system of reporting
- FY11 –vendor quarterly reports required in DHS contract
- FY 11 through FY 18 DHS has achieved at least 95% compliance rate

### Results

- >FY 18 RESULT: 99.31%
- ➤ Recognized by the Green Electronics Council in 2015, 2016, 2017, 2018 and 2019 as an "EPEAT Purchaser Award" winner
- Saves resources, energy, and money

### **U.S. Department of Homeland Security**

Over their lifetime, compared to products that do not meet EPEAT criteria, the 89,747 EPEAT-registered IT products purchased by the U.S. Department of Homeland Security in 2018 will result in environmental impact reductions including:

- Reduce use of primary materials by 8,368 metric tons, equivalent to the weight of 1,609 elephants
- Avoid the disposal of 70 metric tons of hazardous waste, equal to the weight of 580 refrigerators
- Eliminate the equivalent of 121 U.S. households' solid waste for a year—224 metric tons
- Avoidance of 48.4 metric tons of water pollutant emissions

#### **Energy-Related Savings**

EPEAT's requirement that registered products meet, and often exceed, the latest ENERGY STAR specifications means these products will consume less energy throughout their useful life, resulting in:

- Savings of 26,873 MWh of electricity—enough to power 2,212 U.S. households for a year
- Greenhouse gas emissions reduction of 16,682 metric tons of CO2 equivalents—equal to taking 3,572 average U.S. passenger cars off the road for a year
- \$2,782,370 in lifetime cost savings

## Recognition

In FY 2015, DHS purchased 76,260 EPEAT registered units under the DHS FirstSource II/Eagle II contracts. Over the life of the units, this will save the Department 15.8 million KWh of electricity – enough to power 1,235 homes for a year, and save \$1,194,000.

## Recognition

In FY 2016, DHS purchased 80,658 EPEAT registered units under the DHS FirstSource II/Eagle II contracts. Over the life of the units, this will save the Department 30 million KWh of electricity – enough to power 2,076 homes for a year, and save \$3,109,600.
