TO ALL INTERESTED PERSONS AND PARTIES:

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (EPD) of the Georgia Department of Natural Resources proposes amendments to the Georgia Rules for Hazardous Waste Management, Chapter 391-3-11. The Rule amendments are proposed for adoption pursuant to authority contained in the Georgia Hazardous Waste Management Act (O.C.G.A. § 12-8-60, *et seq*). The Director of EPD certifies that the amendments of Rules 391-3-11-.01, 391-3-11-.02, 391-3-11-.04, 391-3-11-.05, 391-3-11-.07 through 391-3-11-.11 and 391-3-11-.16 through 391-3-11-.18 are necessary to exercise certain powers delegated by the federal government to the state for implementing specific sections of 40 CFR Parts 260 – 266, 268, 270, 273 and 279 as detailed in the attachment to this Notice.

EPD proposes to amend Rules 391-3-11-.01, 391-3-11-.02, 391-3-11-.04, 391-3-11-.05, 391-3-11-.07 through 391-3-11-.11, and 391-3-11-.16 through 391-3-11-.18 to include regulations published by the EPA through November 28, 2016. The proposed amendments include adoption of EPA's final "Generator Improvements Rule" and "Hazardous Waste Export-Import Revisions." The Generator Improvements Rule reorganizes, consolidates and clarifies the hazardous waste generator regulations to make them easier to understand and more user friendly. The rule also allows very small quantity generators (previously known as "conditionally-exempt small quantity generators") to send their hazardous waste to a large quantity generator under the control of the same person, and for very small quantity generators and small quantity generators to generate episodic amounts of hazardous waste without being subject to additional regulation. The Export-Import revisions consolidate all hazardous waste export and import regulations into one concise section and allow for importers and exporters to submit required paperwork to EPA electronically.

This notice, together with an exact copy of the proposed Rule amendments, a synopsis, and a statement of rationale of the rule revisions, is being provided to all persons who have requested in writing that they be placed on a notification list.
