NETI Online Closing Out



On January 17, 2013, NETI Online will be closed out in favor of NETI's new Learning Management System (LMS) that will store eLearning courses on EPA's Adobe Connect server. The new LMS will have the ability to track user data, such as slides viewed, answers to test questions, and test scores. Learners will be able to access courses on the new LMS via <u>NETI's internet page</u>.

Transcripts

You are responsible for getting a copy of your transcripts off NETI Online. To do this, please follow <u>these instructions</u>. We recommend that you retrieve your transcripts off NETI Online no later than December 31, 2012.

Future eLearning Courses

Courses on the new LMS will be developed using the Adobe eLearning suite software, including the eLearning authoring tools Adobe Captivate and Presenter, as well as programs for editing animations, images, and sounds.

Future eLearning courses will be Sharable Content Object Reference Model (SCORM) compliant and 508 compliant. SCORM is a collection of current eLearning standards and specifications of LMS's whose purpose is to allow the easy transferability of courses to different LMS platforms. Additionally, all future eLearning courses will be compliant with Section 508 of the Rehabilitation Act, which requires that courses be accessible to people with disabilities that is comparable to access available to others, who are not individuals with disabilities.
